DEADLINE FOR NOMINATIONS: March 31, 2010

From the cobbled streets of Colonial Burlington City to the farmsteads surrounding Mount Holly to the bog iron furnaces of the Pine Barrens, Burlington County has a rich history that spans over three centuries. The exploration and understanding of history is essential to understanding the people, places and events that make Burlington County the place it is today. In an effort to encourage the stewardship of the history of Burlington County, the Burlington County Office of Cultural Affairs and Tourism is seeking nominations for an annual countywide History Recognition Program. The program recognizes county residents, organizations and municipalities who have taken steps to explore, record and reveal history, as well as those who have proven to be remarkable leaders and educators in the field of history. This program will be administered in conjunction with the Historic Preservation Recognition Program.

The Burlington County History Recognition Committee, established by the Cultural and Heritage Affairs Programs Advisory Board, will review nominations and make recommendations for awards to the Board of Chosen Freeholders. Each winner and honorable mention will receive a commemorative plaque and certificate. This program is administered by Burlington County Division of Cultural Affairs and Tourism.

History Recognition Program GUIDELINES FOR NOMINATIONS

1. Nominations must be typewritten on a History Recognition Award nomination form. The forms may be duplicated, and digital files of the form are available from the Division of Cultural Affairs and Tourism. **Each nomination, along with seven copies, should be delivered or postmarked no later than March 31, 2010 to "History Recognition Program", Division of Cultural Affairs and Tourism, Historic Smithville Park, PO Box 6000, Eastampton, NJ 08060-6000. 2. Nominated people/organizations must be located or reside in Burlington County. History topics on the 17th, 18th, 19th, and early 20th centuries are equally eligible.
3. For Categories A, C, and D, nominations are not limited to history projects completed in 2009. *Projects completed at any time between January 1, 2004 and December 31, 2009 are eligible for nomination.*
4. Explain why a commendation is in order, giving detailed supporting information. The Division of Cultural Affairs and Tourism staff will review the nomination for completeness. Applications lacking sufficient detail may be returned for revision. An extension of 5 calendar days will be given for revision.
5. Where possible, please submit a recent color photograph that shows the person, project or program with the application. Digital images in .jpg format (300dpi, min. image print dimension 3"x 5") may be submitted on a CD-R. If appropriate to the nomination, more than two images may be submitted. **Please note. Photographs and CD-R will not be returned.** Other supporting information, such as newspaper articles and brochures may be included, but are not required. Please read the nomination form carefully for additional requirements.
6. All history projects must be complete by the time of nomination.
7. Within the nomination and when applicable, please include any applicable information about any public funding sources or grants used.
8. Please list any partnerships or participants where applicable.
9. Self-nominations are acceptable.
10. One History Award and one Honorable Mention will be given for categories A, C and D, and a maximum of two awards will be given for Category B. Awards may not necessarily be given in all categories each year. A maximum of 8 Awards and Honorable Mentions will be given in any year, regardless of the number of qualified nominations. Qualified nominations not receiving an award are welcome to submit nominations in following years, if desired.

NOMINATION CATEGORIES

There are four (4) categories of recognition:

- A. **Published History**
This award category recognizes published works on county history and includes books, brochures and websites.
- B. **Achievement and Leadership**
This award category recognizes individuals or organizations that have made a significant contribution to the stewardship, promotion and dedication to the history of the county. Please note that a maximum of two awards will be given annually for this category and nominations are welcome in following years should the number of qualified nominations exceed the awards on any given year.
- C. **Education**
This award category recognizes excellence and innovation in educational programs dedicated to the history of the county. In addition to grade school and university educational programs, this category might also include the recognition of museums, after-school programs, art and performance programs, etc.
- D. **'New' History**
This award category recognizes efforts in expanding the scope of Burlington County history by highlighting new approaches and perspectives to the understanding of the county's past. This category might, for example, recognize efforts towards the understanding of historical issues relating to gender, culture, industry, civil rights, agriculture, etc.
